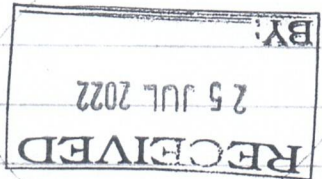

PLEASE FORWARD ME WRITTEN CONFIRMATION OF THE CORRECT AND CURRENT  
OPI REF. NO. FOR THIS MATTER.

ALSO, 'MATTER No. 4, JODIE FEAST AND DCS RPB' RELATED, WITHIN MY  
ORIGINAL COMPLAINT DOCUMENTS (HAND-WRITTEN), I IDENTIFIED DIGITAL  
DOCUMENTS WHICH I REGARDED AS 'MATERIAL EVIDENCE FOR MY CRIMINAL AND  
CORRUPTION COMPLAINTS', AND, THAT I AM NOT PERMITTED TO OBTAIN,  
THEREFORE, REQUESTED OPI TO OFFICIALLY OBTAIN SAME DOCUMENTS AT EARLIEST  
CONVENIENCE BEFORE STATE GOVERNMENT DESTROYS THEM.

DIGITAL DOCUMENT (A), IS A HANDY-CAM AUDIO-VISUAL OFFICIAL

BEGINNING OF THE VPP (LATE 2017), PARTICIPANTS TOLD ALL THE  
VIDEO CAMERA FOOTAGE IS KEPT FOR ONLY 5. YEARS AND THEN  
DESTROYED BY DCS.

PLEASE OBTAIN FULL COPY OF SAID VIDEO FOOTAGE, AND MY  
VPP PARTICIPANT SCANNED COURSE DOCUMENTS (PDF, AS DESCRIBED  
ABOVE), FOR YOUR INVESTIGATION, WITHOUT DELAY. THEY ARE  
SIGNIFICANT MATERIAL EVIDENCE.

PLEASE NOTIFY ME IN WRITING, WHEN OPI/ICAC HAS A FULL COPY



OF SAID DIGITAL DOCUMENTS (CAMERA PLUS PDF), SO I DON'T HAVE TO WORRY ABOUT STATE GOVERNMENT 'DESTROYING IT TO PREVENT IT FROM BEING USED AS MATERIAL EVIDENCE'.

NOTE: SOME TIME AGO, ON THE PRISONER COMPUTER REQUEST SYSTEM (KEX), I OFFICIALLY REQUESTED THROUGH CASE MANAGEMENT, THE MATERIAL DESCRIBED ABOVE IN 'DOCUMENTS (A)' AND 'DOCUMENTS (B)', BE OFFICIALLY MAINTAINED IN SECURE FILES, AS 'I CLASSIFIED THEM AS MATERIAL EVIDENCE IN CRIMINAL AND CORRUPTION COMPLAINTS BEING PREPARED BY ME'.

THAT KEX REQUEST, DAYS LATER, I WAS TOLD BY COTTAGES AREA CMC TRACY (WHO WAS THE COTTAGES CMC AT THAT TIME), 'HAD BEEN ONFORWARDED TO THE RELEVANT DEPARTMENT'.


