

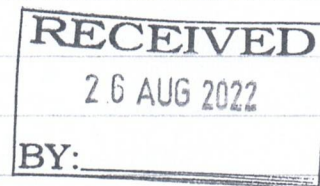

RE - ADDITIONAL DETAILS

'MATTER No. 6', C.I.R. REFERENCE NUMBERS

IN RELATION TO 'MATTER No. 6', MY 1994 MURDER TRIAL, DR. HARRY HARDING (SAFSC EMPLOYEE OUTSOURCED TO MY DEFENCE LAWYERS, AS A PROFESSIONAL WITNESS, AN EXPERT IN SPECIFIED FIELD, WITHIN WEEKS LEADING UP TO VOIR DIRE).

IN MY ORIGINAL COMPLAINT SUBMISSION, HAND-WRITTEN MATERIAL (DESCRIBING DR HARDING BEING ILLEGALLY INTIMIDATED AND THREATENED, RE HIS DEFENCE REPORT CONTENTS, AND, INTENDING TESTIMONY IN MY VOIR DIRE AND TRIAL, BY HIS EMPLOYER, THE STATE GOVERNMENT VIA HIGH-POSITIONED SAFSC EMPLOYEES), AND, ATTACHMENTS (PARTICULARLY A LETTER FROM MY LAWYER, R. PERROTTA, TO ME AND DATED COUPLE OF YEARS AGO, PRIMARY SUBJECT THEREIN WAS DR HARDING'S SIT-DOWN WITH R. PERROTTA, AND INCLUDED DR HARDING REVEALING 'AFTER FINISHING HIS VOIR DIRE TESTIMONY, UPON RETURNING TO SAFSC DIRECTOR BILL TILSTONE 'TOLD HARDING THAT CONSEQUENTIAL TO HARDING'S VOIR DIRE TESTIMONY,

A CRITICAL INCIDENT REPORT/COMPLAINT HAD BEEN INITIATED AGAINST DR HARDING, AND ALSO THEREIN, MY LAWYER MADE AN OPINION ABOUT WHAT APPEARED TO HIM AS PROFESSIONAL IMPROPRIETY AGAINST DIRECTOR TILSTONE AND THE PSYCHOLOGIST WHO DR HARDING WAS SENT TO RE CRITICAL INCIDENT REPORT.

C.I.R. (CRITICAL INCIDENT REPORT), LIKE ALL RELATED GOVERNMENT DOCUMENTS, MUST HAVE SPECIFIC REFERENCE NUMBER/S ATTACHED TO THEM, ASSOCIATING ALL RELEVANT DOCUMENTATION FROM ALL RESPECTIVE PERSONS, DEPARTMENTS, AGENCIES, FOR THE DURATION OF PROCESSES AND PROCEDURES ASSOCIATED WITH THE INDIVIDUAL C.I.R.

I HAVE PROVIDED OPI WITH SUFFICIENT SPECIFIC DETAILS ABOUT SAID C.I.R. GENERATED AGAINST DR HARDING, BY SAFSC, AT THE TIME OF MY 1994 MURDER TRIAL.

IT SHOULD NOT BE DIFFICULT FOR OPI/ICAC COMMISSIONER TO OBTAIN COPY OF SAID C.I.R. FROM STATE GOVERNMENT RECORDS, SAFSC RECORDS, PLUS, ALL DOCUMENTATION PRODUCED BY GOV. AS PART OF THE DUE PROCESS OF THAT C.I.R., INCLUDING:

DATE IT WAS INITIATED?

WHO INITIATED IT, AND, WHO APPROVED IT?

ETC, ETC, ETC....

ALSO DR HARDING OFFICIALLY COMPLAINED ABOUT 'HIS TREATMENT BY SAFSC SENIOR STAFF, MONTHS AFTER MY 1994 TRIAL', SO ALL THAT GOVERNMENT DOCUMENTATION, AND RESPECTIVE REFERENCE NUMBERS ARE ALSO ABLE TO BE VERIFIED AND OBTAINED BY OPI/ICAC, FROM GOVERNMENT RECORDS/ARCHIVES.

AS PREVIOUSLY INDICATED BY ME, MY LAWYER R PERROTTA, HAS HAD FACE-TO-FACE CONVERSATIONS WITH DR HARDING, AND SO MY LAWYER IS A FIRST-PERSON WITNESS TO WHAT DR HARRY HARDING TOLD HIM, ABOUT 'WHAT WAS DONE TO HARDING BY HIS EMPLOYER, WHEN, AND BY WHOM'.


DR HARDING ALSO HANDED OVER A STACK OF DOCUMENTATION TO MY LAWYER, RELEVANT TO THIS MATTER.
