RE "COGNITIVE DISTORTIONS" DECLARATIONS BY STATE GOVERNMENT.

MINISTER

THE STATE GOVERNMENT OF SOUTH AUSTRALIA, BY WAY OF CORRECTIONAL SERVICES OPERATIONAL DOCUMENTS SPECIFICALLY RELATING TO ME, HAS 'OFFICIALLY AND FORMALLY DECLARED, AND STATED, THAT I HAVE "COGNITIVE DISTORTIONS", WHICH THE <sup>PAROLE BOARD</sup> THEN RELIES UPON TO FORM PART OF ITS DECISION, TO REFUSE ME RELEASE FROM PRISON (ON BEHALF OF STATE GOVERNMENT), THAT BOARD ~~IS~~ ALSO STATES, THAT, IT CANNOT TRUST ME TO OBEY AND COMPLY WITH COMMUNITY CORRECTIONS STAFF BECAUSE OF 'MY DISTRUST TOWARDS CORRECTIONAL SERVICES', LINKING TO SAID "COGNITIVE DISTORTIONS"?

I AM STILL WAITING TO BE TOLD BY ANYONE WHO REPRESENTS SOUTH AUSTRALIAN GOVERNMENT'S CUSTODY OF ME, EXACTLY WHAT THE S.A. GOVERNMENT IS ACCUSING ME OF HAVING "COGNITIVE DISTORTIONS" ABOUT. NOBODY HAS TOLD ME,



OR SUGGESTED TO ME EVEN, YET APPLY SUCH ACCUSATION AGAINST MY 'PERCEPTION OF REALITY', TO SUBSTANTIATE GOVERNMENT'S ONGOING CUSTODY OF ME.

THE FACT THAT I HAVE NEVER BEEN PROVIDED WITH ANY DESCRIPTION, OF WHAT I AM ACCUSED OF BEING "COGNITIVELY DISTORTED" ABOUT, IS CONCERNING TO ME! IS IT ANYTHING ASSOCIATED WITH ANY OFFICIAL COMPLAINT MADE BY ME, SUCH AS TO THE GOVERNOR, THE ATTORNEY-GENERAL, CORRECTIONS MINISTER, ICAC COMMISSIONER, OFFICE OF PUBLIC INTEGRITY, OMBUDSMAN, SAPOL ANTI-CORRUPTION BRANCH, AUSTRALIAN HEALTH PRACTITIONER REGULATION AGENCY, SA DIRECTOR FOR PUBLIC PROSECUTIONS? ALTERNATIVELY, IS IT ANYTHING THAT MY LAWYER, MR R PERROTTA ALSO REPRESENTS ME FOR, IN PARTICULAR IN RELATION TO 'ARSON PROSECUTION AND CONVICTION AGAINST ME FROM 1993', OR EVEN, 'MURDER PROSECUTION AND CONVICTION AGAINST ME FROM 1994', OR POSSIBLY, '2002 RESENTENCING OF ME, AGAINST STATE GOVERNMENT'S INTERPRETATION OF THAT 2002 SENTENCING ORDER'?

FROM WHATEVER CORRECTIONAL SERVICES AGENCY/DEPARTMENT SAID "COGNITIVE DISTORTIONS" ACCUSATION IS MADE, REGARDLESS OF WHOMEVER THE INDIVIDUAL ACCUSORS ARE, I REQUEST A FORMAL WRITTEN REPLY FROM SA GOVERNMENT, TO THE FOLLOWING QUESTIONS (AS A WRITTEN/TYPED DOCUMENT IS THEN TANGIBLE EVIDENCE OF GOVERNMENT'S OFFICIAL STATEMENT):


Q.1. PLEASE ITEMISE SPECIFIC EVENTS/CIRCUMSTANCES, WHICH I AM CLAIMED BY CORRECTIONAL SERVICES REPRESENTATIVES, TO BE COGNITIVELY DISTORTED ABOUT?



- Q.2. WHAT SPECIFIC CLAIM/STATEMENT/DESCRIPTION AM I ACCUSED OF BEING COGNITIVELY DISTORTED ABOUT?
- Q.3. TO ACCUSE ME OF 'SUFFERING FROM/HAVE COGNITIVE DISTORTIONS, AND THEREFORE SUFFERING FROM/HAVING A FALSE SENSE OF REALITY', MUST MARRY TO A CONFLICTING BELIEVE (OR VERSION OF EVENTS AND/OR CIRCUMSTANCES), BY RESPECTIVE ACCUSOR, THEREFORE, WHAT IS THE RESPECTIVE ACCUSOR'S VERSION/DECLARATION OF REALITY, FROM WHICH THE ACCUSOR ACCUSES ME OF HAVING A COGNITIVE DISTORTION?

I APPRECIATE THAT SOURCE MATERIAL (REPORTS/DOCUMENT), MAY BE CREATED BY DIFFERENT CORRECTIONAL SERVICES PARTIES, INCLUDING DCS COMMUNITY <sup>CORRECTIONS</sup> ~~CORRECTIONS~~ (FOR 2019 AND 2023 PAROLE APPLICATION HEARINGS), DCS REHABILITATION AND PROGRAMS BRANCH, VIOLENCE PREVENTION PROGRAM FACILITATORS (VPP IN 2017/2018), HOWEVER, REGARDLESS OF RESPECTIVE DOCUMENTS CLAIMING THAT I AM COGNITIVELY DISTORTED (PAROLE BOARD, RPB, ETC), IT IS APPROPRIATE FOR THE RESPONSIBLE MINISTER TO REPLY TO ME VIA OFFICIAL MINISTER'S MAIL.
