FRIDAY 14-10-2022, I TELEPHONED THE OFFICE FOR PUBLIC INTEGRITY,
AGREED TO OPI 'RECORDING MY CONVERSATION WITH THEM', THEN I
INFORMED OPI OF YOUR 'LETTER REQUEST TO ME DATED 10-10-2022'.

I OFFICIALLY 'AUTHORISED OPI TO RELEASE IN FULL, ALL OF THE
MATERIALS, DOCUMENTATION, ETC. WHICH I SUBMITTED TO OPI, AND
WHICH HAVE OPI REF. No. 2022/004071, INCLUDING FROM THE
ORIGINAL SUBMISSION DOCUMENTS, AND ALL OTHER ADDITIONAL
DOCUMENTS I HAVE SUBMITTED IN REGARD TO MY ORIGINAL SUBMISSION

THE OPI ACKNOWLEDGED (DURING MY 14-10-2022 PHONE CONTACT), THAT 'THIS IS AN UNUSUAL SITUATION, CONCERNING NOT ONLY MY OPI COMPLAINT (2022/004071), BUT ALSO, THE SIGNIFICANT AMOUNT OF DOCUMENTS OPI RECEIVED FROM ME, AND, THE GOVERNOR'S CONSIDERATION OF MY PETITION, HOWEVER, THE OPI DOES NOT HAVE A PROBLEM WITH ME FULLY RELEASING/DISCLOSING ALL OF MY SUBMISSIONS TO THE OPI'.

I ALSO ASKED THE OPI (ON 14-10-2022), ABOUT POSSIBLY RELEASING A DIGITAL COPY OF MY OPI SUBMISSIONS (2022/004071), TO THE GOVERNOR, PARTICULARLY AS THE OPI SCANS ALL PAPER DOCUMENTS I SENT THEM? OPI INDICATED (ON 14-10-2022), THAT RELEASING A DIGITAL COPY ~~WOULD~~ WAS NOT A PROBLEM.

I FURTHER INDICATED TO THE OPI (ON 14-10-2022), THAT, DUE TO THIS 'UNUSUAL SITUATION', I DON'T KNOW WHO WILL REPRESENT THE GOVERNOR'S CONSIDERATION OF MY PETITION FOR RELEASE, BUT I HAVE NO PROBLEM WITH OPEN COMMUNICATION BETWEEN OPI/ICAC, MY LAWYER MR R. PERROTTA (PERROTTA LEGAL, MOB. 0413 805 389), AND ATTORNEY-GENERAL'S OFFICE/CROWN SOLICITOR'S OFFICE, IN CONSIDERATION OF MY PETITION TO GOVERNOR, WHICH MAY ALSO INCLUDE 'CONFIRMING CERTAIN DETAILS/CLAIMS BY ME', WHICH MY LAWYER MR R. PERROTTA IS FAMILIAR WITH/AWARE OF.
